- 2. Discussion/possible action of nuisance/violation of Montague Municipal Code 17.32 for 500 W. Webb St: Notice of violation has been sent via certified mail in late June. Multiple trailers on property that have had people staying in them. Trash build up in the backyard. Since notice was sent and contact has been made, there has been some clean-up and small improvements. Code enforcement will stay on top of it and ensure that there is improvement. Table.
