- 2. City Engineer's update for October 2023: Jose presenting. 6th Street report 10/3 was the start date. A change order was submitted to add 4 inches of base to the road, \$33,000 left so Dave decided to do an overlay on King Street. About \$2000 was left after everything was complete on 10/22. Caltrans says the road needs to be widened so that will be addressed before ending the contract.
- 3. Planning Commission's update for October 2023: Robinson absent. Dunn presenting. Report attached.

- 1. Consideration for use of city lot behind Community Hall for New Year Celebration by Chaki Vang: Mayor states that you do not need permission. Dismissed.
- 2. Consideration of approval for the proclamation of the 16th Annual "Read Across Siskiyou" event: Approved. Motion made by Jackson, seconded by Dooley. All Ayes.
- 3. Public Hearing City of Montague Housing Element Update: Proposed Update of the General Plan Housing Element for the 6th Cycle Planning Period (2023-2031) (Discussion/Action)
 - i. Finding that the project would not have a significant effect on the environment and is exempt under Section 15061(b)(3) of the California Environmental Quality Act (CEQA) Guidelines. (Discussion/Action) Approved. Motion made by vela, seconded by Dooley. All Ayes.
 - Approve Resolution 23-07, A Resolution of the City Council of the City of Montague Adopting the 2023 Housing Element Update. (Discussion/Action) Approved. Motion made by Dooley, seconded by Jackson. All Ayes.
- 4. Consideration of approval for budget corrections for FY 23/24: Approved. Motion made by Jackson, seconded by Dooley. All Ayes.
- 5. Consideration of the delegation of funds from Happy Camp Complex Fire Camp: Dunn presenting. Public Works has a mower that was made in 1995 and they have a loader that you must go to a wrecking yard to find parts for because they are not made anymore. The City will be receiving funds from CalFire for loaning them city property and Public Works would like to put the \$79,820 into a separate Public Works fund in LAIF to buy equipment to replace the others that were mentioned. Council counters with stating Public Works can have the money that was made from renting the property but the money that was made from use of drinking and potable water will go into the general LAIF for Parks and Recreation projects. General Consensus.
- 6. Consideration of payment for repair of engine number 510: Chief Vela reporting. 2002 engine donated to the Montague Fire Department from May 10 Fire crew. After a couple uses the engine blew up. Found a mechanic in Medford OR that can fix it for \$32,179.50. The fire department will be selling another engine 511 for \$40,000. The city will need to send a wire transfer of \$16,000 as soon as possible. The rest of the bill will be paid when the engine is finished. Approved. Motion made by Vela, seconded by Dooley. All Ayes.

Any person seeking to challenge a Planning Commission decision made as a result of a proceeding in which by law a hearing is required to be given, evidence is required to be taken, and the discretion in the determination of facts is vested in the Planning Commission, shall be required to commence that action 90 days following the date on which the decision becomes final as provided in Code of Civil Procedure Section 1094.6. Please refer to Code of Civil Procedure 1094.6 to determine how to calculate when a decision becomes "final."

CHALLENGING DECISIONS OF CITY ENTITIES The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City of Montague is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision, including without limitation Government Code section 65009 applicable to many land use and zoning decisions, Government Code section 66499.37 applicable to the Subdivision Map Act, and Public Resources Code section 21167 applicable to the California Environmental Quality Act (CEQA). Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. Government Code section 65009 and 66499.37, and Public Resources Code section 21167, impose shorter limitations periods and requirements, including timely service in addition to filing. If a person wishes to challenge the above actions in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Montague, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.
